ORDER OF EXCLUSION FROM
NOOKSACK TRIBAL LANDS
 PROPOSED
 FINAL

THIS MATTER came before the Court on a Petition for Permanent Exclusion of the Respondent, on Sept. 9, 2022. The Respondent, appeared did not appear and is in default.

The Court having heard arguments in open court and having reviewed the petition, together with the records and files herein, enters the following:

ORDER

IT IS HEREBY ORDERED THAT RESPONDENT IS PERMANENTLY EXCLUDED FROM THE TERRITORIAL JURISDICTION OF THE NOOKSACK INDIAN TRIBE, AS DESCRIBED BELOW:

See Exhibit A (Description of specific tribal lands)

1 I. BASIS

2 REASONS FOR EXCLUSION: The Court finds reasonably certain that:

- 3 1. The Respondent is not a member of the Nooksack Indian Tribe.
- 4
- 5 2. The Respondent's exclusion is necessary to protect the health, safety, and welfare
- 6 of the Nooksack Indian Tribe.
- 7 3. The Respondent has:

8 Committing an act which violates the criminal or civil laws of the Nooksack Indian Tribe,

9 whether or not the Tribe has jurisdiction to prosecute the person for the act.

10 Any act which violates the criminal laws of the State of Washington or of the United

11 States of America, whether or not the person may be prosecuted by the State or United

12 States.

13 Evading arrest or prosecution for an offense committed in another jurisdiction.

14 Failure to comply with any legal process, notice, subpoena, order, or other decree issued

15 by the Nooksack Tribal Court, Tribal Council, or any tribal administrative procedure panel.

16 Removing or attempting to remove any child of a member of the Nooksack Indian Tribe

17 without proper authority.

18 Any act causing physical loss or damage to property not his or her own.

19 Disturbing or destroying grave sites, artifacts, or other sites and objects of historical or

20 anthropological value without authorization from the Tribal Council.

21 Unauthorized possession of, taking, or injury to natural resources within the territorial

22 jurisdiction of the Nooksack Indian Tribe.

23 Hunting, fishing, woodcutting, driving livestock, or dumping without authorization from

24 the Nooksack Indian Tribe.

25 Repeated violation of tribal, county, or state traffic regulations.

26 Interference or threats to interfere with the business activities of the Nooksack Indian

Tribe.

Failure to pay tribal taxes, assessments or user fees.

Inducing any member of the Nooksack Indian Tribe to enter into a grossly unreasonable

contract of any nature.

Committing usury against any tribal member.

Defrauding any member of the Nooksack Indian Tribe of just compensation for labor or

service done at the request of the non-member.

Repeated harassment of members of the Nooksack Indian Tribe, tribal officials, or tribal

1 employees.

2 Photographing, tape recording, or interfering with any ceremony without permission of
the participants.

3 Failure to comply with any tribal law, policy, or contractual obligation regarding
employment practices.

4 Repeated breaches of the peace including but not limited to those breaches of the peace
committed while under the influence of alcohol or drugs.

5 Unauthorized removal or attempt to remove tribal property or property of members.

6 Presence within the jurisdiction of the Nooksack Indian Tribe during a time when that
7 person is legally required to be in school. This applies only to persons under the age of
eighteen years who are not members of the Nooksack Tribal Community.

8
9 II. TIME EXCLUSION BEGINS

10 The Respondent is hereby permanently excluded, effective immediately.

11 III. TIME LIMIT

12 THIS ORDER SHALL BE IN EFFECT UNTIL: PERMANENT.


13 IV. OTHER

14 1. A review hearing shall be scheduled for March 10, 2023 at 9:30am to
15 review the status of this order, and make any modifications and/or amendments as
may be necessary for the best interests of the Tribe, and its Members.

16
17 2. The Respondent may request a hearing for a modification and/or amendment of
18 this Order at any time upon a showing of a substantial change in circumstances,
which shall include successful completion of (1) any criminal sanctions in state,
19 federal AND tribal courts and (2) of Domestic Violence Treatment Program.


