I would also like to see the homes up for conveyance turned over to those ready for ownership. These are some of the focusses that I would like to see addressed.

I have the four years' experience with the current council seat, and I have also earned my BA in Tribal Governance and Business Management. Background in Health, Gaming and some Natural Resources I have experience with.

Being one person at the table I will do my best to work with the rest of the council membership to protect that of what we have as Nooksack, and to grow in positivity.
